### Product description

Normasol® is a single use sterile isotonic topical irrigation solution contained within an easy to open sachet.

Normasol® consists of:

- Sterile 0.9% w/v Sodium Chloride (Ph. Eur.) Solution

Content:

Sodium chloride Ph. Eur., purified water Ph. Eur.

### Indications for use

Designed for use in topical irrigation, wound cleansing, irrigation of mucous membranes and rinsing of eyes. Only for external use.

### Contraindication(s)

- **NOT FOR INJECTION**

### Instructions for use

Normasol® should be used by or under the supervision of a qualified health care professional.


1. Clean/swab both sides of the sachet before opening.
2. Hold sachet with longest side vertical and dotted line at the top. Open/tear sachet along the dotted line, as marked by an arrow on the sachet seal.
3. Product is single use. Discard any unused solution.

### Special storage conditions and handling conditions

- Do not store the product above 25°C.
- Keep away from sunlight/keep away from heat.
- Store the sachets in the outer container (plastic pouch).
- Disposal should be handled according to local environmental procedures.

- Do not use after the expiry date printed on the sachet.
- The sachet packaging is flexible. Upon opening, care in handling should be taken to avoid spillage of solution.
